Travel

This covers athletes and officials travelling outside the Republic of Ireland / Northern Ireland on an official Athletics Ireland Event/Meeting.

Cover club events or individual athlete's travel.

Pre-existing medical conditions.

Travel by persons over 80 years of age.

Policy Excess:

7 days for bodily injury (maximum payable is 104 weeks) OR
€50.00 for Loss of / or Damage to Baggage.
