## **Climate Action and Sustainability Policy**

## 1. Background

Over the last number of years there has been a growing realisation that global warming is placing our planet and future generations at risk. The complex challenges ahead require actions by all of us to meet the goals of the Paris Climate Change Agreement.

Around the world, governments, cities, and businesses are taking climate action, leading the way towards a more sustainable future. Ireland has set a target to reduce carbon emissions (greenhouse gas emissions) by 51% by 2030, and to achieve a climate neutral economy by 2050. As a sporting body, we can play our part in helping Ireland achieve their goal and play our part as a climate leader to a greener more sustainable future.

### 2. Objectives

As a national sporting body, we aim to display climate leadership by actively engaging in the climate neutrality journey and taking responsibility for our own climate footprint.

Athletics Ireland will communicate its Environmental Policy, as appropriate, with relevant stakeholders and members. We will stive to communicate, educate and adequately train our staff on our Environmental policy. This will generate an awareness of the company's Environmental Policy and that we are striving towards continual improvement regarding environmental issues. We aim to ensure that the Board and Executive identifies, evaluates, and manages solutions to support climate leadership in Athletics Ireland and the community on an ongoing basis to the best of our abilities. This policy supports the five principles of the United Nations Sports for Climate Change:

Principle 1: Undertake systematic efforts to promote greater environmental responsibility
Principle 2: Reduce overall climate impact
Principle 3: Educate for climate action
Principle 4: Promote sustainable and responsible consumption
Principle 5: Advocate for climate action through communication

## 4. Responsibilities

4.1 The Board of Athletics Ireland will ensure that a sustainability register is maintained and reviewed at least annually by the Board. The sustainability register compiled by the CEO will identify and prioritize sustainable actions in line with the United Nations Climate Change principles.

4.2 It is the responsibility of the executive to:

- Contribute to the development and implementation of our sustainability goals
- Communicate and raise awareness of environmental issues in the workplace and promote sustainable action.

- Help identify weaknesses within the sustainability policy and register, and help to identify solutions ad work towards implementing them
- 4.3 The CEO is responsible for the monitoring and compliance of the sustainability policy within the organization. The CEO shall include a sustainability summary in every CEO Board report on progress in implementing the sustainability plan and follow up on all KPI's that will be presented in a report each year.

### 5. Procedures

The CEO shall engage with relevant sub-committees, Board members, staff members and others to compile a sustainability register for Board review.

Athletics Ireland sustainability procedures will be conducted from the three pillars of sustainability which considers economic, social, and environmental aspect, ensuring all three aspects are in equilibrium to achieve sustainability.:

- Economic sustainability-striving for a stable progress over time and applying good business practice.
- Social sustainability-acting as a responsible employer as well as contributing to improved social progress within the geographics we are operating.

• Environmental sustainability-protecting the environment by actively reducing our own and our customers' environmental impact as well and optimising the resource utilisation.
