Minutes of the AGM (virtual) hosted in the AAI Northwood offices via Zoom at 11am on Saturday the 23rd of April 2022.

John Cronin opened the AGM and delivered the President's address.

Good morning, everyone, I will start by thanking everyone who is joining us online and those in attendance at the Athletics Ireland Office to facilitate the event.

In attendance here are Brid Golden, Deputy President & Chair of Coaching and Development, Michael Quinlan Chair of Finance & Risk, Hamish Adams CEO, Gerry Dunne our legal advisor and myself. Daragh Browne (Marketing, Communications & Sponsorship Manager) and Deirdre Marley (Office & Registration Manager) are facilitating the webinar, Kieron Stout (National Children's Officer & Human Resources Manager) will be taking the minutes. John Holian (Finance Director) will assist with any queries on the financial side while our Auditors will be joining us online at the appropriate time.

Again, a warm welcome to the Board Members, Life Vice Presidents and delegates from the County Boards and Provincial Councils who are joining us online. This will be the fourth AGM held on line; the 2020 AGM, the 2021 Congress & the 2021 reconvened Congress and today. Earlier in the year when we had to decide between virtual and in person there was still uncertainty about Covid numbers and venues, and it was thought best to go with virtual at the time.

I am sure many of you will be glad to know that the 2023 congress is planned to be in person and I will announce the details at the end of today. The AGMs in non-Congress years like today should probably be left open, perhaps virtual is the best fit given that there is no voting on motions and approval is required only for three important items to fulfill the legalities of the Companies Act in the Financial area following presentations given by the Auditors and the

Chair of Finance and Risk, bookended by the President's address and the CEO Report.

Having said all that, I am sure you all agree it is great to see the Pandemic moving to the rear-view mirror although it is still very much part of our day to day lives and will be for the considerable future. All elements of our organisation are to be commended for the outstanding contributions that were made to keep our sport going through some very dark days. To call out everyone would put us at risk of missing the Road Relays in Raheny tomorrow, so a sincere and appreciated thank you to all.

Since Congress, the Board was fully formed with the addition of 3 co-optees (Greta Hickey, Nuala Hunt and Claire Shannon) who are making a valued contribution with their business world experience and a background in our sport. I am joined here by my Deputy Brid Golden, who has been a great support to me and leads the Coaching and Development Committee, and Michael Quinlan Chair of Finance & Risk who will present on the Finances later on. The other Chairs of Principal Committee online - Fintan Reilly High Performance, Andrew Lynam Competition and Evelyn O'Reilly Juvenile, like Michael are all in their first term in their roles and have hit the ground running. As mentioned earlier the Pandemic made things very difficult and our Committees, Staff, all our volunteers and others adapted to keep as much as possible ticking over and were very innovative in finding solutions to unprecedented problems.

David Abrahams Athletics Northern Ireland, Laura Brennan IUAA and Rory Friel ISAA also are active members of the Board. The Board composition is completed by your regional representatives Brendan McDaid Ulster, PJ O'Rourke Munster, Brian Bruton Connacht and Greg Duggan Leinster. The Board decisions are outlined in the Board Bulletin which I hope you find useful. Our Board has only been able to meet virtually since Congress and I look forward to an in person meeting soon.

The new Governance Committee has been formed as per motion of Congress 2021 and has commenced its work. One of its first recommendations will come into force after this AGM when the role of Company Secretary will no longer be held by the President. While not illegal, modern governance thinking recommends separation.

As we near the end of the first quarter of a century since the formation of AAI, it is a good time to review how our Board is made up. The way our Board is constituted could be described as representative, except for the 3 co-optees. This has been the tradition and has served us well. However, there are two other dimensions coming into play namely skills based and gender balance.

Many modern opinions suggest it should be skills based: currently the 3 co-optees help towards closing some of the gaps identified from the skills matrix of the other members. The

third dimension is Gender Balance with Sport Ireland looking to have 40% by the end of 2023. I am glad to report we are at 38% at present.

To get all three dimensions for want of a better word “balanced” will require constitutional changes. With the next Board being formed at Congress 2023 it would be good to work with the seven units who appoint to the Board to achieve the Gender Balance in the first instance while the constitutional elements are being worked out.

A year out from the next Congress, I would ask members to consider running for the Principal Committees, keeping in mind that gender balance is an objective throughout our organisation and it is good to get a mixture of new and current members.

The CEO and I had the opportunity to meet virtually with the four provincial Councils and the Dublin County Board as part of the traditional method of communicating between AGMs. We have a planned face to face visit with the Cork County Board next month. These meetings are always worthwhile and are an occasion to give updates and receive feedback. Before Congress 2023 it is hoped that these can be repeated in a face-to-face manner. It is difficult to visit everywhere and we rely on the Delegates at the Provincial Council to bring the information back to their own County Boards. However, if any County Board would like a visit please let us know.

During these meetings, a proposal for a One Day Licence was outlined with the purpose of generating much needed funding for High Performance and Coaching with the added benefits of insurance and an integrated results data base. The system is being trialed during the Irish Runner/National Championships Road series and will be reviewed by the Board along with any feedback received. As mentioned in the communications about the One Day Licence so far, please feedback any concerns or enhancements for consideration.

Communications in any organisation is always difficult and with all the platforms we use, hopefully, it is continually improving. However, communication is two way and we welcome feedback at all times.

2022 is the year of celebrating historical events in our sport. On July 19th it will be one hundred years since the NACA was formed which occurred shortly after Independence. This was followed by our membership of World Athletics in 1924. The then President JJ Keane is the first name on the Presidential chain of office which I was proud to have been bestowed with at my inauguration last May. There are plans to celebrate this centenary towards the end of the year which will be announced later.

At the end of June our National Senior Track and Field Championships will be the 150th edition and will be longest continuous National Track and Field Championships in the world.

Hopefully a big crowd will join us to celebrate the occasion. 2023 brings us the 150th anniversary of the first University Championships with a planned return to the first location, Cork.

It was great to see the return to competition with a nearly complete outdoor season in 2021, a wonderful cross-country season culminating in magnificent Championships in Santry, Gowran and Castlelyons. The indoors saw a near return to “hanging from the rafters” at some of the events. I had the pleasure of visiting each of the provincial Juvenile championships and the National Championships to present the Star Awards. This was special, as I had been the recipient of one of these awards nearly a lifetime ago!

The achievements of our High Performance athletes will be outlined by Hamish later. Anyone who watched the 2021 Annual Awards held virtually for the first time, will have seen the depth of the outstanding performances which have continued into 2022. Best wishes to HP and all our athletes and their support teams who will represent Ireland in this unique year at the World Championships in Eugene, Oregon and the European Championships in Munich along with all the other international events. The Athletes Commission championed by our previous President Georgina Drumm, is now in place.

I extend my sincere thanks to Hamish Adams our CEO and the Athletics Ireland staff who have continued to work tirelessly in difficult circumstances on the road back from the Pandemic. Hamish will outline the activities of the organisation later in his report. It is a pleasure to work with Hamish and the staff and it wonderful to see the mutual respect and cooperation between staff and volunteers at all levels as we live our values. Welcome to new staff members Ava McManus Marketing, Rachel Ormrod & Aileen Byrne Participation and Geraldine Stewart Competition who joined since Congress 2021.

Both Hamish and I represented Athletics Ireland at the European Athletics Congress in Lausanne. Athletics Ireland became early participants in the European Athletics Focus Federation programme as Hamish and members of his staff visited European Athletics Headquarters for a very worthwhile exchange of how a National and a Continental organisation functions. As part of the same programme Hamish and I also went to a European Athletics Council meeting in Madrid and made a well-received presentation on Athletics Ireland and joined the Council meeting for a day. Thanks to all the agencies, sponsors and partners for their invaluable help and support. A liaison meeting between Athletics Ireland, Ulster Athletics Council and Athletics Northern Ireland was held virtually.

The world has been shocked in recent weeks by the atrocities that are taking place daily in the Ukraine. It is truly heartbreaking to watch as a nation is decimated by war. In line with World and European Athletics we condemn these deplorable actions. Many Ukrainian

refugees have arrived in Ireland to stay with us for a while. We wish them all well and we welcome all Ukrainians who are joining our clubs around the country. Thank you all for what you are doing in your areas for these people who are suffering so much.

As I come to the end of my address, I would like to highlight one item that exemplified what Athletics Ireland and its members, constituents and partners can achieve. The 2021 European Cross Country Championships held at the Sport Ireland Campus on December 12th 2021 were considered to be one of the best, if not the best ever held, I am delighted to say this is not self-praise, but universal feedback. Those that were lucky enough to be there would have had "an experience of a lifetime". I express my thanks to the LOC led by Liam Hennessy and to HP and our team who finished an outstanding third in the medal table and every person involved. It was the last event held before John Treacy the CEO of Sport Ireland retired and it was a fitting occasion for John a "Champion of our Sport" and we wish him well in his retirement.

I wish to sincerely thank you all for your support during my first year as President. It has been a pleasure and a privilege to work with you all and lead our wonderful sport. I look forward with excitement to the coming year.

Finally, I would like to take this opportunity to remember those from our Sport who have passed away since Congress 2021, may they RIP. I don't have a comprehensive list but would like to mention a few who will be representative. At any time, I would encourage the County Board and Provincial Councils to let me know of the names of any members past and present who have passed on.

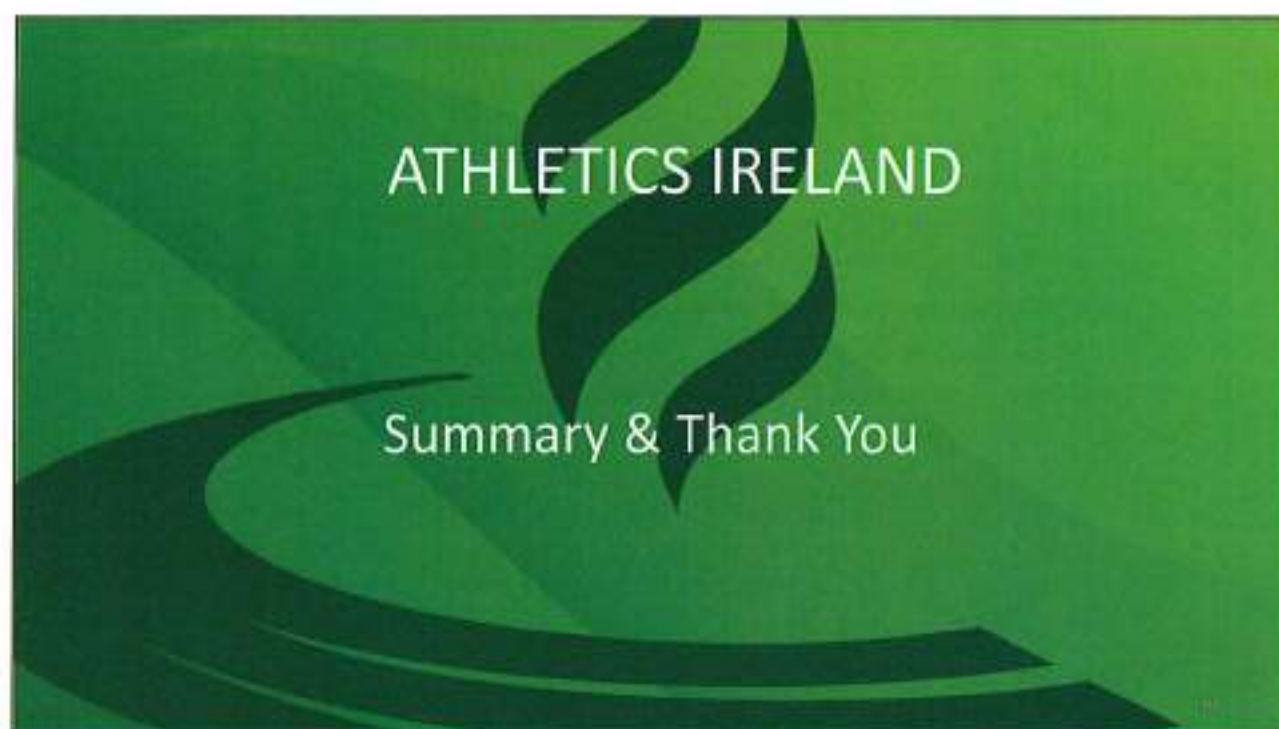
